for the dates of service is mandatory. It may be proven with a Report of Separation (DD-214) or other Military
Records, Veterans Administration paperwork, Pension records, etc.

☐ <u>A Veteran (Proceed to Step 5)</u> is defined as an individual who served at any time during the period from 1 November 1955 to 15 May 1975 not dependent on service location during Vietnam.
